You will be required to agree to these terms each club year (July - June) prior to being accepted as a member of Nashoba Valley Photo Club ("NVPC", "us", "we") and granted all the rights and benefits of that membership (herein "Service").

Access and use of the NVPC website ( <a href="https://nvpc.visualpursuits.com/">https://nvpc.visualpursuits.com/</a>) operated by NVPC will require members to accept an independent on-line website agreement when logging in for the first time each club year.

#### **Behavior in Club Meetings and Activities**

Following the incident, those members of the executive board who witnessed the event will vote on a course of action appropriate to the behavior, which may include removing the member permanently from the club. Any executive member involved in the incident will abstain from voting. In the event of removal from the membership, dues will not be refunded to the member.

#### **Significant Issues and Disagreements**

If a member has a serious issue, whether with an action or activity, or with inappropriate behavior of another member, the concerned member shall approach the President or Vice President to express their concern. The Executive Committee will meet within 14 days, if feasible, but no later than 30 days, to resolve the issue.

#### **Website Terms & Conditions**

Upon logging into the website for the first time each year, you will be required to accept an independent on-line website agreement.
